DEAR MR LECKEY

FURTHER TO MY MOTHER' FAX TO YOU YESTERDAY, WE FEEL THAT THERE IS ONE OTHER CRUCIAL PIECE OF INFORMATION I WISH TO STATE.

SHORTLY AFTER CONOR WAS ADMITTED TO CRAIGAVON AREA HOSPITAL ON THE  $8^{\text{TH}}$  MAY 2003, WHILE STILL IN ACCIDENT AND EMERGENCY, HE SUFFERED THE FIRST OF THE VERY UNTYPICAL SEIZURES THAT HE SUFFERED FOR THE REST OF THE DAY AND THIS WAS WITNESSED BY A YOUNG MALE DOCTOR, WHO WE JUST BRIEFLY SAW. HE STATED THAT CONOR WAS IN HIS OPINION HAVING A GRAND MAL SEIZURE AND "JUST BECAUSE YOU, VE NEVER HAD ONE BEFORE DOESNT MEAN YOU CANT HAVE ONE". I CANT REMEMBER EXACTLY WHAT TIME THIS WAS BUT IT WASNT VERY LONG AFTER THE FAST DRIP HAD STARTED GOING INTO CONOR, I THINK PROBABLY IN AND AROUND 11.40ISH. I FEEL IF THIS DOCTOR RECOGNIZED THIS AS A SEIZURE THAT HIS INPUT IS VERY IMPORTANT AS NOBODY ELSE IN THE MEDICAL STAFF SEEMED TO LISTEN TO US FOR THE REST OF THE DAY BEFORE IT WAS TOO LATE FOR CONOR. I WAS NEVER GIVEN HIS NAME AND DIDNT SEE HIM AGAIN BUT SURELY HIS REMARKS SHOULD HAVE BEEN NOTED ON CONORS CHART. I FEEL SURELY SOMEBODY SHOULD KNOW WHO THIS DOCTOR IS .
