### **Indicative achievements in recent posts**

Because of my continuity as Regional Director of Public Health through multiple organisational changes it is more appropriate to provide an indication of achievements in my post over recent years:

#### **Local**

Over the course of my professional career there has been a significant decline in the engagement of clinicians in primary prevention activities. In order to release some of the enormous potential of medical consultant staff in local NHS Trusts, I established, in 2010, a programme of Clinical Prevention Fellowships. We have appointed six consultants from a variety of specialties as Fellows. They have the support of their Director of Public Health and spend one half day per week working on their chosen prevention project. They range from a paediatric anaesthetist from a burns unit who is determined to reduce scalds in toddlers, to a psychiatrist specialising in eating disorders who is working with commercial and council gyms to educate them on helping with people with potential anorexia nervosa.

Providing high quality leadership to Directors of Public Health (DPHs), the strengthening of local public health teams and improving the quality of their work, in both a Primary Care Trusts (PCT) and Local Authority (LA) context, has been a key task. The only Healthcare Commission annual health check that rated public health (in 2006/7) said; 'Within the public health domain, South West strategic health authority area had the highest proportion of primary care trusts declaring either good or excellent progress (50%), in comparison to (the) strategic health authority area with the lowest proportion (8%)'. In the past four years there has been an unparalleled development in public health, with all PCTs required by the Strategic Health Authority to invest a fixed percentage of their growth monies in public health.

For the past six years I have operated a system of annual local public health performance discussions with the 14 PCTs and 16 top tier LAs in the South West. These highly valued discussions take place with the Chief Executives of the PCT and LA plus their DPH and are informed by a comparative and longitudinal data set ranging across not only the usual public health outcomes but also including indicators such as excess winter deaths and completeness of health checks on children in care.

As part of a personal voluntary commitment to the reduction of health inequalities I spent 18 months in 2005-6 as independent co-chair of 'Community at Heart', the New Deal for Communities project for the most deprived part of inner city Bristol. This £50m pound project is improving the lives of residents and my successful contribution was to develop the governance of the project and foster effective links with the NHS. My role was to improve the corporate functioning of the organisation and in particular to support the Chair.

#### **Regional**

I have built an efficient and highly effective public health team at regional level. The South West was the first region to merge its cancer registry with its Public Health Observatory. This generated efficiencies and laid the basis for an effective integrated intelligence network providing key data analysis and interpretation to clinical networks, the public health community and the public.

In the last four years I have personally initiated a number of significant collective public health initiatives. The three most important are:

- SmokeFree South West: A regional Office for Tobacco Control established in 2009 and based on the successful model from California and elsewhere in the USA. Funded collectively by the PCTs to

the tune of £2.5m it is tackling tobacco on all fronts. Its media and training activities have transformed local performance on smoking cessation; it is implementing the first public campaign on hand rolling tobacco in Europe; and is working with HM Revenue and Customs on a major initiative on illegal tobacco. <http://www.smokefreesouthwest.org.uk/>

- Healthy Schools Plus: Building on our performance as the region with the best achievement in the national Healthy Schools programme and responding to pressure from schools for a further phase of work on health in schools, in 2008 we developed an innovative and challenging new programme. Healthy Schools Plus is funded by DH and the PCTs and is aimed at improving pupil health in the 50% of schools with the highest uptake of free school meals. It has been enormously successful and we are now exploring turning the organisation into a social enterprise. <http://hsplus.healthyschools.gov.uk/>
- Office for Sexual Health: In 2010, frustrated by the ineffective silo-based approach to improving sexual health, I negotiated transfer of staff and funds from the Department for Education, the Health Protection Agency and the Strategic Health Authority to create an integrated sexual health team. This has had an immediate effect, particularly through its establishment and operation of a peer review process for LAs and PCTs. Since arriving in the South West I have chaired and very actively led training and development in public health. We ran the first integrated medical and non-medical training programme in the UK and have led the way on a variety of fronts. A notable recent success (2007 – 10) has been the investment of £300k in funding local government employees in the region to undertake academic courses in public health up to Masters level. This has resulted in more than 50 staff from backgrounds such as planning, transport and leisure services developing an understanding and appreciation of how they can contribute to improving health.

Facing considerable population growth and the prospect of numerous urban extensions I was determined to try and ensure that these were health-enhancing places for people to live and work. I particularly wanted DPHs and local authority directors to see what could be achieved. I approached colleagues in the WHO Collaborating Centre for Healthy Cities and Urban Policies at the University of the West of England (where I hold two visiting chairs) and they identified Freiburg in Germany as an outstanding example of urban planning for sustainability. We planned a study visit for 2008 and invited DPHs in the South West to take part. It was however a condition of their participation that they were accompanied by at least one senior colleague from their local authority. The visit was an outstanding success and resulted in important changes in some of the local authority areas involved. In 2009 demand from other local areas resulted in a second, equally successful, study visit.

## **National**

Two of the major public health related third sector bodies, Sustrans and the Soil Association, have their national headquarters in Bristol. I have developed particularly strong working relationships with both and we have undertaken a substantial number of joint projects. Examples of the projects we have worked on are:

- With our help in 2010 Sustrans produced a new evidence file for highway authorities to present the value for money of the increasing range of measures that encourage a shift from car use to more sustainable modes.
- I have a long history of engagement in healthy and sustainable food issues (reinforced by experiences during the foot and mouth outbreak) and in 2008 worked with the Soil Association and the Food For Life Partnership in the developing, piloting, application and inspection of the Food For Life Catering Mark. In 2004 I applied to, and was appointed by, the NHS Appointments Commission as a Non-Executive Director of the National Treatment Agency for Substance Misuse (NTA). I took on this additional responsibility because having been an Executive Director on NHS bodies I wished to experience and learn more of the Non-Executive Director role. I also wished to improve my limited knowledge and experience of substance misuse policy and delivery. I have made an active contribution to the success of the NTA and in particular have played a role in altering the Agency's approach to Local Area Agreements from hostility to participation, and have also been instrumental in improving the monitoring and reporting of performance to the Board.

In the early phases of Local Area Agreements (LAAs) there was an absence of leadership from the Department of Health centrally. I established and chaired the LAA Forum which brought together the LAA leads from all nine regions of England on a monthly basis to review progress and deal with problems arising from the setting and negotiation of local targets and rewards. As a result of these efforts, Department of Health teams became successfully engaged in the LAA process in each region, some policy branches of DH became advocates of LAAs as a means of delivering policy goals, a substantial proportion of targets set at local level were around health and wellbeing and substantial sums were gained in reward grants.

I have undertaken a Review of the regulation of public health professionals for the four Chief Medical Officers of the UK. This was published for consultation along with the Government's White Paper on Public Health in November 2010.

On behalf of the three Strategic Health Authorities involved, I chaired the NHS review of the commissioning of services for patients with learning disabilities who were residents of the Winterbourne View hospital run by Castlebeck Ltd. The review was completed in November 2011 and forms part of the series of investigations into this failure of care.

### **International**

For a number of years I have been a member of UK delegations to the World Health Assembly, the Executive Board of WHO when the UK has been a member, and have represented the Chief Medical Officer (CMO) at the biannual European meetings of the CMOs. I have drafted successful resolutions; spoken on behalf the UK in committee; and organised and chaired successful parallel sessions on behalf of the UK. I am used regularly by CMOs of other European countries as a source of expertise and advice.

The World Federation of Public Health Associations represents national public health bodies across the world and is recognized as the global representative of public health organisations. It has however been in a semi-moribund state until recent years. I have been instrumental in its revitalization and in 2010 joined its Executive Board as one of its three European members. I also serve on the Finance and the Policy committees. From 1<sup>st</sup> January 2012 I will take over as Treasurer of the organisation. I believe that the injection of energy and experience that I, and a few others, have made has created an organization of importance and substantial potential.

From my student days onwards I have had an engagement with international health issues. I have carried out a number of assignments for the UK Government and development bodies. These have mostly had a very positive impact and received positive feedback from both recipients and funders. Family and work commitments have prevented lengthy overseas commitments in recent years although I have undertaken a number of shorter and valuable pieces of work in Ireland. I regard it as an achievement to have managed to make this international contribution and combine it with a successful role in public health in the UK

### **Budgetary and Staff Responsibilities**

The range of budgetary and staff management responsibilities involved in the above posts have varied from £50m and almost 1,000 medical staff in the late 1980s, £240m and 40 staff in the late 1990s and £6m and

200 staff in 2010. This included several years as head of all NHS education and training functions for the South and West of England during which I led a successful and complex re-tendering exercise for nurse training thus saving many millions of pounds.
