 (d) lead implementation of the NICS Healthy Workplace Policy.

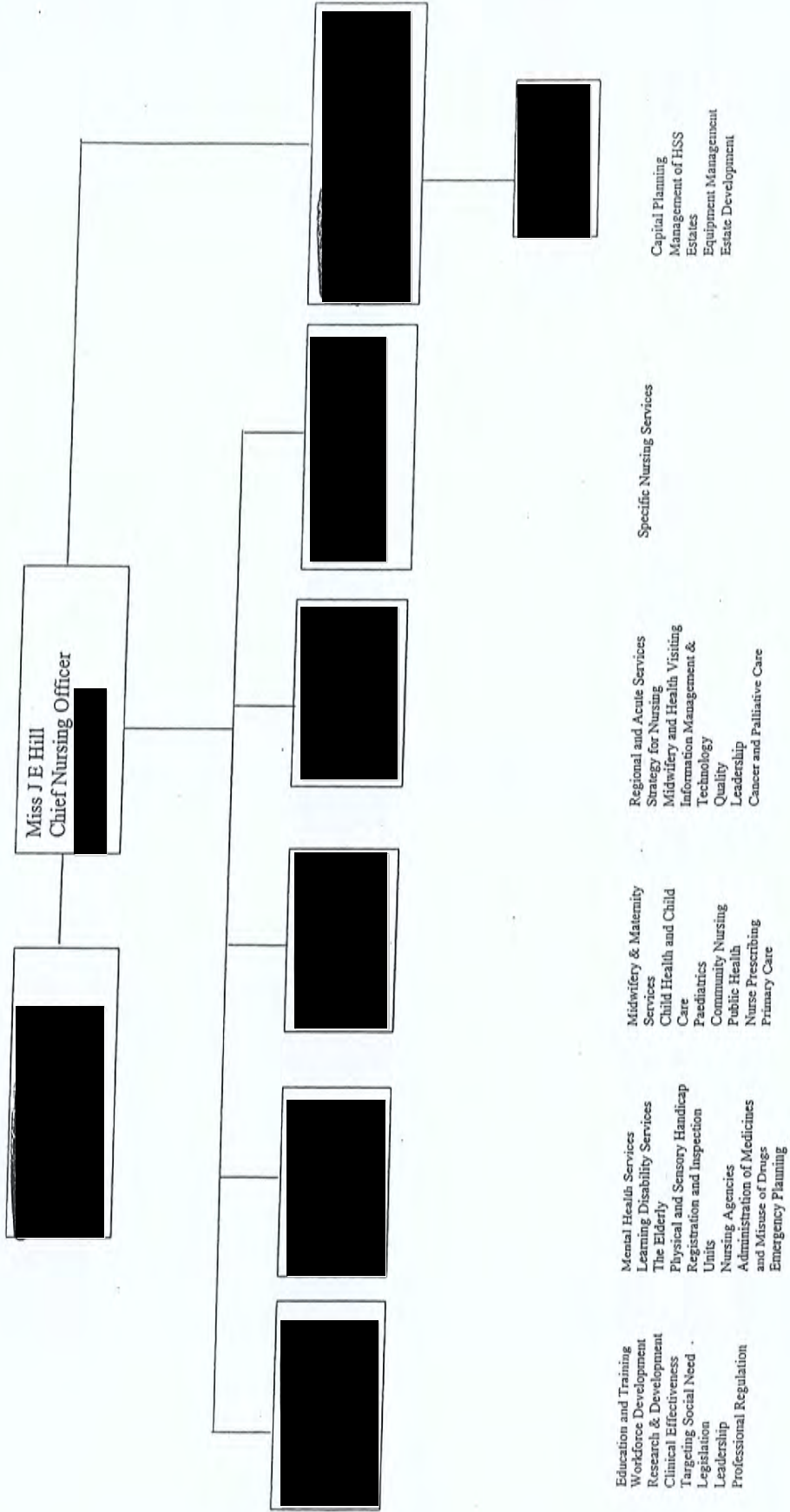
