
UPON HEARING reading the papers filed, including the affidavit of the Plaintiff and the letter of consent from the Defendant; dated

IT IS ORDERED AND DECLARED THAT:-

1. Subject to the conditions set out in the Schedule to the Order dated 4<sup>th</sup> October 2012 ("the Schedule"), disclosure by the Defendant to the Plaintiff of:
  - (i) Currently redacted sections in the medical notes of W2 that were provided pursuant to the Order made by the Lord Chief Justice on Wednesday 10<sup>th</sup> October 2012 which concern the calculation, prescription and/or administration of 'Midazolam' ("Relevant Medical Notes")

is lawful in the public interest notwithstanding any obligation of confidence or privacy pursuant to the Human Rights Act 1998 otherwise owed in respect of such documents and information.

2. The Defendant shall forthwith produce an unredacted copy of the Relevant Medical Notes to the Inquiry, for use in the Inquiry on the basis that:
  - (i) Nothing shall be published and no part of the document shall be read into the public record or otherwise put in the public domain which might, whether directly or indirectly, lead to identification of W2 or the family of W2
  - (ii) Save for the disclosure required by this Order, the redacted Relevant Medical Notes shall continue to be treated in accordance with the Order made by the Lord Chief Justice on Wednesday 10<sup>th</sup> October 2012 in relation to confidentiality and anonymity
3. There shall be permission for any party to apply to the Court in connection with the implementation of this Order.
4. There shall be no order as to costs.
