I remember seeing Dr Maurice Savage and Nurse Catherine Murphy. There were also two other doctors and various other night staff.

They were there to see my sister and Adam.

5. Please describe any discussions you had with any medical or nursing personnel at RBHSC <u>pre-surgery</u> and what, who and when you had these discussions.

None of the medical or nursing personnel discussed Adam with me.

There were no such discussions with me.

We were only told that this was a one in a million thing.

We were told that much would depend upon a CT scan.

#### e. What would be done to find out what had happened

We were not told anything about this.

Dr Savage and Dr Taylor came into the family room at the same time. We were told that it was a one in a million thing.

I was totally shocked by how extremely bloated he was. He looked huge. He did not look like himself at all.

No one was allocated to us.

b. whether the support given to you was either adequate or appropriate.

I was in shock. I do not remember any support being given to us.

13. Please state if you were asked by RBHSC or the Trust to be involved in any way with a discussion about what happened to Adam and any lessons to be learned from his death. If so, please explain your involvement (if any), and state who asked you to be involved and when.

No one from anywhere ever asked me to do any of this.

I was not contacted by anyone.

15. Please provide and explain any further information or comments that you wish the Inquiry to have.

I feel that we could have been given more information about the true nature of Adam's condition while in PICU as I feel this prolonged our anxiety. I appreciate that all hope could not be taken away but I think we could have been prepared for the outcome better.

I would also like to say that Adam did not have a permanent limp. He had a fall while at the zoo on his 4th birthday in August. He had obviously picked up a minor injury from this. Neither did he have a twitch. He was a perfectly bright and bubbly little boy who loved life and was keen to learn.
