  - (b) Set out your understanding of the purpose of that meeting.

    As I do not recall meeting with both parties I cannot answer this question.
  - (c) What was your understanding of Mr. Fee's purpose in speaking to you? I met with Mr Fee on numerous occasions, 4 years after Lucy's Death Mr Fee requested a statement from me of the events that occurred.
  - (d) What was your understanding of Mr. Fee's purpose in speaking to Sister Traynor? I have no way of knowing Mr Fee's purpose in speaking to Sr Traynor I was not present.
  - (e) Confirm whether the comments attributed to you in the record at Ref: 033-102-295 have been accurately documented. If the comments are inaccurate, please explain any inaccuracy and clarify what you believe you did say.

I cannot recall meeting as stated with Mr Fee and Sr Traynor together. When Mr Fee documented that he "spoke to Staff Nurse Swift" line 5-10,

(Reference No. 033-102-295) he was speaking to me alone.

To clarify for accuracy - Dr O'Donohoe prescribed the IV Fluids which I know commenced as an infusion.

(3) Did you have any concern about any issue relating to the fluids prescribed/administered to Lucy or how this was done?

To answer point A&B of this question - I had no concerns about fluids prescribed or administered to Lucy or how it was done. Normal procedures were followed as per Trust guidelines.

We know now that Lucy died as a result of Hyponatraemia.

- (b) The role performed by you, the Sperrin Lakeland Trust or others in terms of the steps that were taken to reach conclusions in relation to the cause of Lucy's death; I was not directly involved in determining the cause of Lucy's death. I cannot comment on the role of the Sperrin Lakeland Trust.
- (c) The procedures which were followed in order to review or investigate issues relating to the cause of Lucy's death;
  As requested by Mr Fee at least 4 years after Lucy's death, I gave a statement of my actions on the night shift that Lucy was admitted.
- (d) Lessons learned from Lucy's death and how that affected your practice at the Erne Hospital or elsewhere;

No. 18 Solution is no longer used on Children's Ward. Normal Saline and 5% Dextrose became the normal I.V Fluid administered to Children at risk of developing Hyponatraemia, fluid prescribed, dose calculation and electrolyte monitoring became much more rigorous.

Paediatric parental fluid therapy (1 month – 16 years) was not implemented until September 2007.
