As a Grade G Sister my role was to manage and co-ordinate the care of patients by a multidisciplinary team, ensuring they were cared for in a professional manner within a safe environment in the unit.

(f) How was the management and supervision of the nursing staff working on MAU organised between yourself and the Grade F Nursing Sister (Sister Elizabeth Brennan/Dickey) when each of you were on duty in or about May 2003.

Each wing of MAU is divided into two teams. There is a nurse in charge on each wing who allocates nursing staff to work in each team and this is done at the beginning of each shift. The nurse in charge on both wings liaise with me on a regular basis to update me on the status of each patient. This system was in place in May 2003.

- (2) Describe in detail the education and training you have received in fluid management, the prevention of hyponatraemia and record keeping in relation to fluid balance, to include any particular training relating to fluid management in children, and provide dates and names of the relevant institutions/bodies, by reference to the following:
  - (a) Undergraduate level.

As a student nurse fluid balance management was part of my training

- (b) Postgraduate level.
- (c) Hospital induction programmes.
- (d) Continuous professional development.

As part of my continuous professional development I attended training in the administration of paediatric intravenous infusions, the completion of the paediatric fluid balance chart and the triggers for reporting clinical incidents related to hyponatremia in Craigavon Area Hospital on 13th October 2009.

With reference to the content of Conor's CAGHT Hospital Casenotes, please provide clarification and/or further information in respect of the following:

(3) At any time on the 8th May 2003 did you have any involvement in the nursing care provided to Conor while he was a patient in MAU? If so, provide a detailed account of the care which you provided.

I was not responsible for any aspect of Conor's care.

(4) If you were responsible for any aspect of Conor's nursing care while he was a patient in MAU, and if you made any entry in his case notes with regard to his condition or care, refer to that entry and transcribe the entry which you made.

- (5) At any time on the 8th May 2003 did you have any involvement, directly or indirectly, in supervising the nursing care provided to Conor while he was a patient in MAU? If so, provide a detailed account of the care which you supervised, and how you exercised that supervision.
  - Shortly after Conor's arrival to MAU bed space F1 located on the back wing Sister Brennan advised me that this was not a suitable environment for him to be and he was being moved to a side room located at the front wing of MAU which had become available. I agreed with Sister Brennan's judgement that this was appropriate for Conor.
- (6) If you had no involvement in supervising the nursing care provided to Conor while he was a patient in MAU, who was responsible for exercising supervision of that care, and how did you expect this supervision to be exercised?
  - Sister Dickey/Brennan was in charge of the front wing of MAU and was therefore involved in supervising the nursing care provided to Conor.
- (7) Who was responsible for managing Conor's fluid needs in the Medical Admissions Unit during any period when he was a patient there?
  - Medical Staff were responsible for prescribing the fluids Conor needed and nursing staff were responsible for administration and recording the fluids.
- (8) Do you know why no record made of fluid output in the Intake/Output Chart (Ref: 088-004-063) in respect of Conor?
  - I do not know why there was no record made in the fluid output in the Intake/Output Chart
- (9) Who was responsible for completing the Intake/Output Chart when Conor was a patient in MAU?

  The nursing staff that were allocated to his care on the front wing of MAU.
- (10) Who was responsible for supervising the person(s) responsible for completing the Intake/Output Chart when Conor was a patient in MAU? How would you have expected such supervision to have been exercised?
  - The nurse in charge on each shift of the front wing of MAU would be responsible for supervising the nursing staff in their delivery of patient care. I would expect that the nurse in charge would be ensuring staff caring for patients had their documentation completed accurately. All staff are trained in record keeping and are accountable and responsible for keeping up to date documentation on each patient they care for.
- (11) Was there any process in place in 2003 in the MAU of Craigavon Area Hospital for ensuring that nurses with responsibility for completing fluid management records (such as intake/output charts) did so in a manner which complied with best practice? If so, fully describe that process, and clarify whether it applied to Conor's case?

The process that was in place was, all student nurses have fluid management record keeping (such as input/output charts) as a core element of their training. Each member of nursing staff were responsible and accountable for ensuring all patients who had intake/output records were accurately completed. This did apply to Conor's case.

The 2002 guidance was not brought to my attention.

- (a) Who brought the Guidance to your attention?
- (b) When was it brought to your attention? In particular were you aware of the Guidance before you had any dealings with Conor?

Guidance on hyponatraemia was first shared with me in September 2009.

I was not aware of the 2002 guidance before Conor's admission to MAU.

(c) In what way was the Guidance brought to your attention?

I was made aware that Hyponatraemia training was being set up for all nursing staff who cared for children for 0-16 years in September 2009.

(13) Insofar as you are aware, was the Guidance brought to the attention of the other nurses working in the Medical Admissions Unit, whether before or after Conor was treated there?

As far as I am aware nursing staff in MAU were not aware of the Hyponatremia Guidance for 2002 before Conor's admission to MAU, the nursing staff were made aware of these guidelines in September 2009.

- (14) Have you ever received training in the use or application of the Guidance and if so state,
  - (a) Who provided you with training?

Practice Development Team in the Southern Health and Social Care Trust provided the training.

(b) When and on how many occasions have you been provided with such training?

Two occasions -on 13th October 2009 and 11th October 2011.

(c) What form did the training take?

13th October 2009: 2 hour session - PowerPoint presentation.

11th October 2011: Questions & Answers Competency Assessment

(d) What did you learn from the training?

I learned that all staff caring for patients between the ages of 1- 16 years must maintain a competent level of knowledge and skills on fluid management, the need to adhere to the DHSSPS Paediatric Parenteral Fluid Therapy Guidance (1-16 years) September 2007, to recognize inappropriate intravenous fluid calculations and prescriptions and take appropriate action, importance of completing intake and output charts accurately, recognising the signs and symptoms of Hyponatremia and the need to take action if blood results are outside the normal reference range (contact Doctor).

(e) Was the training of an adequate quality or standard for the work that you do?

Yes.

All nursing staff caring for under 16 year olds must have attended training in Hyponatraemia. All guidance is available for consultation at ward level to follow accurately.

Yes.
