Stella,

Further to your query re: Medical Director Meetings with CMO, the early meetings were quite informal. They were set up to provide a two-way channel of communication between CMO and Trust MDs. They were somewhat 'ad hoc' in nature and intended to mirror in some respect the Specialty Advisory Committees (SACs). A draft agenda may have been circulated with notification of the meeting and a request to MDs to submit items for discussion. Very few papers were circulated in advance, due to the absence of any secretarial support for the meetings until relatively recently. We were dependant on Medical Officers from the Department to keep brief notes.

I have checked with CMO's secretary and I know that CMO disposed of all her files prior to August 2003. I am a bit of a 'horder', so my files go back a bit further to the meeting held on 13 December 2001. On scrutiny of these minutes it is noteworthy that no reference was made to any previous meeting,

nor was reference made to 'Matters Arising' from previous meetings. I am sorry that I cannot be more helpful.
