

- 02.11.00 S. Millar indicates family will not agree to meet until they have received the report
- 01.11.00 Letter from Mr. Crawford – B.O'Rawe Expressing surprise at completed review. State they were not notified.
- 10.11.00 Letter from B.O'Rawe to Stanley Millar encourage a meeting
- 22.11.00 BO'Rawe to Mr. Crawford – Explained Clinical review
 - Explained meeting aims
 - Concern about report in isolation
 - Invited S. Millar into the process
- 27.11.00 Phoned request from S. Millar that we share some type of summary of the report
- 12.12.00 Received letter dated 24/11/00 – wanting a formal response to their complaint before entering any discussions
- 10.01.01 – Response to Mr. Crawford by Mr. Mac Crossan
 - Summary of review
 - Invite again to meeting
 - Link with B. O'Rawe encouraged
- 16.03.01 – Letter from Mr. Crawford asking the CE to respond directly allegation “ inadequate and poor quality care”
- 30.03.01 – Response from CE – “the outcome of our review has not suggested that the care provided to Lucy was inadequate or of poor quality”
 - encouraged meeting with Trust Staff
 - encouraged to discuss with S. Millar
 - encouraged to link through BO'Rawe

- October 2001 Senior Counsel opinion on case
 - Agreed external Medical Negligence Report – Dr. Jenkins

- 11.03.03 New contact with the family via intermediary
 - shared within SLT and with CSA – advised could not meet with family while litigation ongoing

expressing an interest in the case

21.04.03 Contact from Coroner and investigation of case be Dr. Sumner

08.04.03 Meeting Dr. Kelly, Donna Scott & Patrick Good (Belfast)
