ICU DISCHARGE SUMMARY

Adam, a 4 months old infant with Bilateral multicystic kidneys, was admitted to the Paediatric Intensive Care Unit on the 28.11.91. He had a ureteric reimplantation done on the 23.11.91 with suprapubic catheter insertion. But he was oliguric and developed acute renal failure over the next week. An Ultrasound scan showed bilaterally hyperechogenic kidneys and his rt kidney was smaller in size. DMSA scan revealed bilaterally abnormal kidneys with abnormal shape and secondary compression of nephrons by the cysts. He was commenced on peritoneal dialysis on the 28.11.91 and the same day laparotomy was performed. At laparotomy there was obvious dilation of both ureters with no significant pelvic or renal dilatation. T tube drainage was performed on both flanks. He has been passing good amount of urine and the fluids are calculated accordingly. The Sr creatine and blood urea values are coming down and FBP, electrolytes are normal. He also has metabolic acidosis. He had pyrexia and vomiting on 2.12.91. Septic workup was done and instituted on antibiotics.

He is on TPN and oral fluids and was transferred to Musgrave Ward on the 3.12.91.
