## Lines to Take: Hyponatraemia-related deaths 1984-2003

- There are approximately 14,500 deaths of adults and children in Northern Ireland each year.
- Data from death certification over the 20-year period 1984-2003 suggest a total of 6 people of all ages have died as a direct result of hyponatraemia.
- A further 55 deaths have occurred in which hyponatraemia was documented as a contributory factor, but not the primary cause of death.
- Hyponatraemia (a low sodium level) is a common electrolyte abnormality in hospitalised patients. Many sick patients, especially elderly people on drug therapies known to predispose to electrolyte problems, may develop hyponatraemia.
- Hyponatraemia may be an associated factor in a patient's death, but is rarely the primary cause of death.
- Guidance was issued in 2002 on the prevention of hyponatraemia in children. Further guidance was issued by CREST on the prevention and management of hyponatraemia in adults.
