On Friday, Dr. Campbell stated:

"At the time of the interview for the UTV Insight programme on Raychel Ferguson on 17 February 2003, I was not aware of any other death from hyponatraemia in a normal, healthy child in Northern Ireland."

Can Dr. Campbell then explain to whom she was referring to when she stated in a letter circulated with the hyponatraemia guidelines on March 25th, 2002.

"Hyponatraemia can be extremely serious and has, in the past few years, been responsible for two deaths among children in Northern Ireland."

Question: Who are the two children the CMO was referring to?
