Seizures 'not witnessed'

There is no evidence that hospital staff witnessed a disabled County Armagh boy having a series of epileptic seizures in the hours before he fell into a coma, a coroner has said.

John Leckey, Coroner for Greater Belfast, said he

believed that on the balance of Area Hospital probabilities 15-year-old Conor Mitchell suffered a number of seizures before a fit that proved to be fatal.

Conor, a cerebral palsy victim from Lurgan, County Armagh, died in the Royal Belfast Hospital for Sick Children last May four days after being admitted to Craigavon Area Hospital,

His family have claimed he experienced between 10 and 12 violent episodes in the afternoon of his admission to Craigavon and they pleaded for nurses to get medical help.

Mr Leckey, presented his findings on Wednesday, the seventh day of the inquest.

He said he had attached due weight to the evidence of three paediatric experts whose view was that the parents of disabled children have considerable information which is of help to medical staff.

But he said there was "no evidence" to enable him to conclude that any member of the medical or nursing staff witnessed the seizures "each of two to three minutes' duration and of increasing severity and frequency, the

Extending his sympathy to the family, the coroner said: "He was a much loved boy, son and grandson."

He added: "I am satisfied that the Mitchell family did know Conor intimately and were in a very special position so far as interpreting his body movements and bearing in mind the medical conditions from which he suffered his body movements would tend to be different from a child not disabled."

Mr Leckey concluded that the teenager had died of brainstem failure caused by a cerebral oedema.

The seizures had been a contributory factor in the swelling which led to brain death.

Mr Leckey said there was no evidence of any viral infection contributing to his death and he concluded that fluid management at Craigavon Area Hospital had been acceptable.

Conor's family have said he lapsed into a coma after suffering the second of two epileptic seizures in the presence of a paediatric registrar.

Tests at the Royal confirmed that Conor was brain dead and the family agreed to his support systems being switched off. He died on 12 May, 2003.



Cerebral palsy teen was treated properly

A FIFTEEN-year-old boy with cerebral palsy had been receiving appropriate treatment at Craigavon Area Hospital as he suffered two serious seizures, a paediatrician told an inquest today.

The inquest heard that after suffering the seizures Lurgan teenager Conor Mitchell lapsed into unconsciousness and was transferred to the intensive care unit.

He was later taken to the Royal Victoria Hospital for Sick Children where he died four days later on May 12 last year.

Conor's family claim that he had suffered 10-12 seizures between the time of his admission at Craigavon around lunchtime and 8pm.

They have expressed con-

They have expressed concerns that his seiznres weren't recognised.

Dr Marion Williams said she was asked to see Conor on the evening of his admission to Craigavon to see if there was any further treatment he should be receiving. However,

she said that the call had not been urgent.

Dr Williams said that although she saw two seizures she had not witnessed the violent body movement which Conor's mother had described.

She said Conor suffered two stiffening episodes—the first was very brief and lasted a few seconds, on the second occasion he stiffened again for about ten seconds but did not recover.

Dr Williams also said the family had not mentioned that Conor had been having seizures when she spoke to them.

"I remember thinking at the time that he was receiving

appropriate management and everything was being done that could be done."

Consultant paediatrician Michael Smith said that when a person suffered a chronic condition in childhood it was desirable for paediatric care to continue on until early adulthood.

However, in this case, Conor had not been under paediatric care for a number of years and it would have been no advantage to him to have been admitted to a paediatric ward at Craigayon.

Asked by Robert Millar, barrister for Criagavon Area hospital, if Conor would have received any different treatment in the paediatric ward, Dr Smith replied; "Based on the clinical situation and with the information, I had, the care would not have been different".

The medical expert said that the cause of death had been cerebral odema but he did not know if the cause of this condition would be determined.

Skipper is fined over collision

A KIRCUBBEN fishing boat skipper who sank a clam dredger because he claimed he s blinded by a low sun habenerged today.

Phillip McMullan of Round Island Park, Sanctuary Cove, Kircubben, admitted negligence over the collision between his fishing boat Aspire and the clam dredger Mariscos, off Burial Island.

Two fishermen aboard the Mariscos had to be rescued following the collision north of Portavogie on December 18, 2002.

The Maritime Accident and Investigation Board launched a probe into the incident and McMullan appeared at Newtownards Magistrates Court this week to face six charges of negligence by failing to use appropriate means to stop and

of failing to maintain a collision.

Six of the charges were dropped after he pleaded guilty to failing to ascertain that risk of collision existed. He was fined £500 and ordered to pay £500 costs.

McMullan told the court

McMullan told the court that the low winter sun had affected his ability to see the Mariscos and claimed his radar picture had become confused by echoes.

The Aspire was returning to Portavogie when it struck the Mariscos in December 2002.

The Mariscos immediately capsized, momentarily trapping two crewmen in the upturned wheelhouse. They both managed to swim free and floated to the surface.

McMullan was not available for comment today.

Doctor rejects seizures finding

A DOCTOR has rejected the opinion of a leading consultant paediatrician who found that a disabled boy suffered a series of major seizures before lapsing into a coma.

Dr Andrew Murdock told a Belfast inquest he did not accept that 15-year-old Conor Mitchell had a number of epileptic attacks in the hours before he fell into unconsciousness.

Conor, from Lurgan, Co Armagh, who suffered from cerebral palsy, died in the Royal Belfast Hospital for Sick Children in May last year, four days after being admitted to Craigavon Area Hospital.

His family claim that he suffered between 10 and 12 seizures between the time of his admission and 8pm and that they had urged nurses to get medical help.

Dr Murdock, a medical registrar based in Craigavon, said he had found no evidence of seizures after examining the stricken boy at 6.30pm on the day of his admission.

Two hours later, while he was being examined by Consultant Paediatrician

Dr Marion Williams, Conor suffered the second of two major seizures and lapsed into a coma. He never recovered consciousness and died in the Royal on May 12, 2003.

Dr Murdock told the inquest: "I didn't see anything in my examination that suggests to me that there was Grand Mal seizures occurring. When there was a seizure diagnosed at 8.20pm, treatment was instantly instigated."

Tommy McKillop, a barrister for the Mitchell family, said that Dr Edward Sumner, a Consultant Paediatric Anaesthetist, concluded that "on the balance of probabilities" Conor suffered seizures during the afternoon.

Disagreeing with the findings, Dr Murdock said he trusted the professionalism of the medical staff in the Medical Admissions Unit, who had not witnessed violent seizures.

The doctor told the inquest that after Conor's

death, he spoke to a number of senior colleagues to see if he could have missed anything during his examina-

tion.

"Their conclusion was that my management had been appropriate. As to the cause of death, there were a lot of theories such as a sudden epileptic attack which can cause sudden death.

"When the post mortem report came back I was hoping that there would be a conclusive answer," he added.

Earlier, Staff Nurse Barbara Wilkinson confirmed the family had been very anxious to speak to a doctor about their concerns that Conor was suffering from spasms and had a rash.

The nurse, who was present when Dr Murdock carried out the 6.30pm examination, said: "I had no problem with Dr Murdock's attitude or the way he examined Conor."

The inquest was adjourned.



Inquest into boy's death

Ms Joanna Mitchell, from Lurgan, Co Armagh broke down as she revealed she had urged nurses to get medical help for son Conor, who suffered from cerebral palsy.

At one stage she claimed Dr Andrew Murdock fumbled during the emergency at Craigavon Area Hospital a year ago.

She also accused Dr Murdock, the medical registrar, of lying when he claimed he did not witness her son`s symptoms before he lapsed into a coma.

Conor, 15, died on March 12, 2003, three days after being transferred to the Royal Belfast Hospital for Sick Children.

Giving evidence on the first day of the inquest at Belfast Coroner's Court, Ms Mitchell said her son began to develop seizures after being admitted to Craigavon on March 8.

``He went completely stiff and his body corkscrewed. Each seizure lasted at least two to three minutes. He suffered 10 to 12 seizures between the time of his admission and 8pm,`` she told the inquest.

The court was told that Dr Murdock was called to see the stricken teenager at around 6.30pm.

- ``Dr Murdock was definitely there fumbling about while Conor was in seizure. Dr Murdock had been there for quite a few of Conor`s seizures. He just hadn`t diagnosed it,`` she said.
- ``He was out of his depth. He told me Conor wasn`t breathing properly. He told me Conor was missing heartbeats.
- ``I asked for Conor to be moved to the Royal and I said would somebody who knows what they are doing please come and see my son,`` she added.

Robert Millar, a barrister representing Craigavon Area Hospital said Dr Murdock had denied seeing Conor suffering any seizures.

Ms Mitchell said she became concerned when her son's face became puffy and he developed a rash. She said she kept calling for help.

``For hours I tried to get help. For hours I watched that.

The court heard that Dr Murdock was called after Conor had suffered a very bad seizure.

``I could see his heart pounding in his chest and he had blood trickling down the side of his mouth. His rash had gone to his arms and chest.

Mr Millar said Dr Murdock had denied seeing a rash.

But she accused the doctor of lying: ``Dr Murdock said he wasn`t worried about the rash because it keeps going away.``

Mr Millar added Dr Murdock would give evidence saying he didn't see any discharge of brown liquid coming out of his mouth.

Ms Mitchell said: ``He`s lying. He tried to examine Conor`s throat when he was having a seizure and he said he was uncooperative.

``He wasn`t unco-operative. He was having a seizure and at this stage he was very very ill.``

The court heard that Dr Murdock carried out a full physical examination of Conor when he was admitted to the ward around 1pm.

He then saw him again five and a half hours later being called by a staff nurse.

Mrs Mitchell said: ``There was five and a half hours that I called for help. My son was getting worse.

``I kept getting told Conor was OK, to stop panicking.``

``I am not making this horror story up. This is what happened to my son. This is what happened to me. This is what is happening every day,`` she told the court.

``I was seeing my son getting worse and worse and worse and I had a doctor telling me he wasn`t. I couldn`t have requested any more strongly for a more senior doctor,`` she added.

Death of teen with cerebral palsy

AN inquest opened in Belfast today into the death-in hospital of a 15-year-old youth who suffered from cerebral palsy.

Conor Mitchell from Franklyn Park, hurgan died at the Royal Belfast Hospital for Sick Children May 12 last year. He had earlier been transferred from Craigavon Area Hospital.

Mrs Mitchell said she thought the drip was emptying quickly and her mother thought Conor's face was swollen and puffy.
