am a Detective Constable in the Police Service of Northern Ireland, presently attached to the Major Investigation Team based at Gough Barracks, Armagh. On Tuesday 17th October 2006 I was on duty at Grosvenor Road Police Station. At 10:18am I spoke to Dr Robert Taylor DOB12/06/58, who had attended as a voluntary attender for a pre-arranged interview into the death of Adam Strain in 1995. I introduced myself to Dr Taylor and cautioned him as per Article 3 of the Criminal Evidence (Northern Ireland) Order 1988 in the following terms, "You do not have to say anything, but I must caution you that if you do not mention when questioned, something which you later rely on in court, it may harm your defence. If you do say anything it may be given in evidence." To which he made no reply. I informed Dr Taylor that he was not under arrest, that he did not have to remain at the police station and that he could consult with his solicitor, Mr Gary Daly, who had accompanied him, at any time. At 10:26am I accompanied Detective Sergeant Cross during an interview of Dr Robert Taylor. This interview was suspended at 11:07am to change the tapes. At 11:08am the interview recommenced and terminated at 11:41am. Dr Taylor then selected a tape from the interview between 10:26am and 11:07am.
