Hi Jay

I have faxed Les Dyer today and I am attaching his reply which was also by fax (attached .pdf file). You can infer from his fax that, as he has replied so promptly, he is most concerned that the Inquiry (as it is presently formulated) might not identify those persons which could be culpable in Adam's death. Having studied the medical aspects of Adam's case, from the viewpoint of a general medical practitioner, I fully support Les's conclusions as an anaesthetists. Unless the opinion which Les is expressing is brought to the attention of the Inquiry, the wrongdoings are unlikely to be made public - ever!

Les has already offered his services to your legal team, without any fee attaching. As you have hear me say before, Adam's death is quite different from those of Lucy and Raychel for several reasons. That is why I have been so keen to have your lawyers listen to Les. [REDACTED] and [REDACTED] would prefer to wait until all the 'written statements' are published on the IHRD website before they hear Les. But I also understand that Les will be going to Uganda for the month of September to work in a mission hospital there. He will not be back until October or later. You may consider that too long to wait to hear what Les has to say. If so, may I encourage you to keep your lawyers informed about all your contacts and listen seriously to their professional advice. Neither Les nor I would attempt to offer you any legal direction.
