RE: ADAM STRAIN

The documentation which the PSNI have received in the course of the current investigation into Adam's death in November 1995 indicates that an attempt was made by a junior doctor to take blood on the morning of the operation for electrolytes. This attempt was unsuccessful.

Adam's mother has stated that two doctors attempted to take blood – firstly a SHO and secondly a Registrar.

Can I ask that these two doctors are identified to us by name and with contact details as we would proceed to interview them as witnesses.


Thank you for your letter requesting information regarding blood sampling for electrolytes prior to Adam Strain's operation.

When Adam was admitted the night before surgery, blood was taken for analysis (including electrolytes) at 9.30pm, and intravenous fluids were prescribed by Dr. Jackie Cartmill (O'Hara witness statement 003 dated 9/10/05). The intravenous fluids were erected by Dr. J. Larkin. S/N Catherine Murphy noted that the drip giving the fluids stopped (tissued) at 1.30am and she so advised Dr. Cartmill. As S/N Murphy notes in her O'Hara Witness Statement 005 dated 18/7/05, although the notes record reinsertion of the cannula at 5am it is felt that this was not successful because of difficulty gaining intravenous access and Adam went to theatre with no IV access having been obtained.

There is no record of attempts to take blood for electrolytes after 9.30pm the night before surgery until blood sampling was undertaken in the operating theatre. The episodes Adam's mother is referring to are more likely to have been the attempts to give intravenous fluids rather than attempts to take blood. Unfortunately the doctors who you refer to as an SHO and a Registrar have not been recorded in the notes. The possibilities are junior medical paediatric staff who were working under Dr. M. Savage or junior anaesthetic staff working under Dr. R. Taylor. I note you have interviewed Dr. Savage and from his draft statement I do not see that he has identified the doctors. I understand you are to interview Dr. Taylor in due course and he may know who these doctors were. I have not seen such doctors identified in the records of the Inquest or in any of the Statements I coordinated on behalf of the O'Hara Inquiry.

Please advise me if you think I could assist further.

RE DEATH OF ADAM STRAIN

Police are aware from the papers available to them that following the death of Adam in November 1995 an examination of the theatre equipment was undertaken by Messrs McLaughlin and Wilson, and that Dr Fiona Gibson reported on this.

Police would like to establish:

1. If an internal review of the circumstances of Adam's death was undertaken by the hospital, with or without external assistance, prior to the Inquest.
2. If the examinations leading to the report of Dr Gibson were part of such a Review.
3. If records exist of such a Review, and if so, that they be made available to police.

Thank you for your letter requesting information regarding the inspection of theatre equipment.

1. Internal Review

Dr. Armour, State Pathologist for the case, had raised concerns regarding equipment (HM Coroner's note, O'Hara Website ref. 011-029-140, 141). H.M. Coroner requested an inspection from Dr. Murnaghan (059-073-166) and this was carried out by Mr. McLaughlin & Mr. Wilson (059-068-157-160).

2. Dr. Gibson's Report

Dr. Gibson's report (059-069-161-162) was the review, and identified no equipment fault relevant to the case, or anything linking three deaths.

3. The Review

The Review comprises 059-068-157-160 and 059-069-161-162 and was forwarded to H.M. Coroner.
