## RACHEL FERGUSON, DECEASED INQUEST HEARING – 26 & 27 NOVEMBER 2002

I refer to the above matter and enclose herewith, for your consideration, copy statement prepared by Dr Raymond Fulton, the Medical Director at Altnagelvin Hospitals Trust at the time of Rachel Ferguson's death which provides detail regarding the investigation of the death and relevant correspondence. I would advise that Dr Fulton is still employed by the Trust and would be available to give evidence at the Inquest Hearing.

I also enclose, for your consideration, a copy letter from Dr Nesbitt, the present Medical Director at Altnagelvin Hospitals Trust dated 1 May 2002 addressed to the Chief Medical Officer and the response dated 10 May 2002 from the Chief Medical Officer. You will note Dr Nesbitt is due to give evidence at the Inquest Hearing.

I also enclose herewith copies of the following statements:-

These nurses are still all employed by the Trust and are available to give evidence at the Inquest Hearing. I note that in earlier correspondence you had advised that you had no objection to receiving evidence from any nurses who were in a position to give relevant evidence regarding the issue of vomiting. Following further consultation with the Trust, these nurses and a further nurse, Staff Nurse Gilchrist, have been identified as the most relevant nursing staff to give evidence regarding this issue. I am presently awaiting a statement from Staff Nurse Gilchrist and shall forward same immediately to you upon receipt.
