Name	Position	Role in Rachel's care
AAH		
GILLILAND, Mr R	Consultant Surgeon	Raychel was admitted under his care - he was the named surgeon, but he didn't see her at any time
BHALLA, Mr N K	Surgical Registrar	Called to Ward around 05.00, after seizure
MAKAR, Mr	Surgical SHO on-call	He initially saw Raychel in A&E, diagnosed appendicitis and carried out the operation. He also visited her the next morning
ZAFAR, Mr	Surgical SHO on-call	Saw Raychel the morning after the operation, on a Ward Round. He was called by CURRAN when Raychel had her seizure - he was in Casualty at the time, and didn't attend until after McCORD
CURRAN, Dr M	Surgical JHO	Prescribed an anti-emetic of Raychel at 22.15. Last doctor to see her before she fitted. He was contacted by JOHNSTONE, and attended the Raychel after her seizure
DEVLIN, Dr	Surgical JHO	Gave Raychel the anti-emetic at 18.00 the day after the operation
McCORD, Dr B	Consultant Paediatrician	He was the Consultant Paediatrician on-call, and was called by TRAINOR after Raychel's seizure
TRAINOR, Dr B	Second term SHO on-call	She was called to see Raychel by JHO, CURRAN, after Raychel had seizure. She hadn't seen her before this
JOHNSTONE, Dr J	Paediatric SHO on-call	Saw Raychel after her seizure - hadn't seen her before this
BUTLER, Dr	Paediatric SHO	Prescribed 2nd bag of fluids for Raychel afternoon after her operation on request from S/N RICE
MORRISON, Dr C	Consultant Radiologist	Carried out CT scans on Raychel after her seizures

Name	Position	Role in Rachel's care

MILLAR, E	Sister (Most senior nurse)	Came on duty morning after Raychel's operation until shortly after 6 that evening. Knew she had vomited and that anti-emetic had been requested
RICE/McAULEY, M	S/N	Looked after Raychel the day after her operation from 08.00 to 20.00 - saw vomits. Got fluid prescription renewed and bleeped surgical JHO several times re vomiting. Eventually DEVLIN came
NOBLE, Anne	S/N	In ward the previous night when Raychel was admitted and straight after surgery. Was there when Raychel had her seizure
PATTERSON, Daphne	S/N	Admitted Raychel into Ward prior to operation - named Nurse - drew up Care Plan. Was on duty next night again, but in Infant Unit. Took bowl of vomit from Raychel's dad at 23.00 and informed nursing staff looking after her. Checked IV pump at 00.00
ROWLSTON, Avril	S/N	On duty during day after Raychel's operation. Dealt with raychel in afternoon, and noted that she had been sick twice
GILCHRIST, Sandra	S/N	On duty the night of the seizure, with NOBLE, BRYCE, & LYNCH. Knew Raychel had been sick several times, had changed bed & later her pyjamas. Also contacted Surgical JHO, CURRAN, about nausea and vomiting
BRYCE, Fiona	S/N	Was on duty night Raychel was admitted and filled out paperwork. On duty next night again - noticed Raychel had been sick at 00.30am, and changed pyjama top
LYNCH, Elizabeth	Nursing Auxiliary	Helped GILCHRIST change Raychel's bed when she had been sick, but didn't see extent of vomit. Father told her she had been sick again and she told GILCHRIST. Saw Raychel fitting and called NOBLE
McGRATH,	RGN (Theatre Nurse)	Looked after Raychel during operation and prior to returning to Ward
