

Re Raychel Ferguson

Thank you for agreeing to review the circumstances surrounding the death of Raychel and to prepare a report for the PSNI.

Following ongoing concern over the death of Raychel and other children in Northern Ireland police have decided to investigate the circumstances of Raychel's death. This may involve interviewing all the doctors involved in her treatment. It would therefore assist the PSNI if you consider and advise us on the roles played by each doctor in Raychel's treatment so that we may establish who may be interviewed as witnesses or advised to seek the advice of a solicitor before interview.

We have obtained a copy of your report to the Coroner, Mr Leckey, for the Inquest on Raychel and it is therefore not necessary for you to repeat the contents of that report.

I provide the following documents for your consideration. They have been obtained from the Coroner's file and were numbered by police in the original copy file. While the numbering of the pages as provided to you is not consecutive, it is adequate for referral purposes and therefore I have not sought to alter it.
