In 1990-91 I worked in Altnagelvin Area Hospital in Orthopaedics and in September 1991 until 2004 I worked in the Erne Hospital in Children's Ward. I resigned in 2004. I remember coming on duty between 0730 and 0745 on 13 April 2000. I was told that Lucy Crawford had been moved overnight to the Royal and I was unaware of her condition. I remember saying to the nurses to ensure the records were up-to-date and later I remember saying to a nurse to put all the records relating to Lucy in a sealed envelope as was standard practice. I remember it was Sally McManus who was handing over to me and Sally told me about Lucy and her transfer to Sick Children's. D/Sergeant Cross has asked if I remember any discussions re fluid regime for Lucy. I do not. D/Sergeant Cross has asked me if a fluid regime of 100 mls of 0.18% saline per hour until a child passed urine was a standard prescription on the Children's Ward. I can say there is standard guidance issued and after the review into Lucy Crawford's treatment there was a lecture to nursing staff to highlight the standard of recording required. D/Sergeant Cross has asked if therapy or support was offered to staff. I would reply there was not a formal debrief but staff were made aware that support was available. That is something that instinctively I would do. D/Sergeant Cross has asked me if I remember any discussions regarding difficulties around Lucy's treatment and the possibility of litigation. 
