INQUIRY INTO HYPONATRAEMIA RELATED DEATHS – ADAM STRAIN

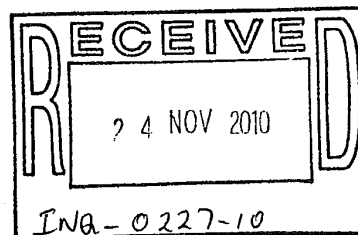
Your letter of the 17th November 2010 lists 8 dates which refer to a different category of hospital attendance, namely the ward attender. There are 4 dates which are recorded on the Clinic attendance listing we have already submitted. One date is the date a Waiting List Board card was completed not a hospital attendance, and one date an episode cannot be identified for.

There remain 3 ward admissions which the Trust cannot explain. They were omitted from the Admissions listing and I apologise for this error. I enclose a revised Admissions and Surgical Procedures listing incorporating the 3 additions and correcting the entry for date 23rd January 1994 (sic) which should read 1995.
