RE: INQUIRY INTO HYPONATRAEMIA RELATED DEATHS

I refer to the above and your letter of 12th September 2011. I reply as follows: -

2) I now enclose updated RGH 3 table setting out chronology of care provided for Adam. The original RGH 3 furnished to you was as complete and accurate as possible at the time it was furnished. I am instructed that Dr O'Neill was eventually identified and the Inquiry has witness statements from him. Despite attempts to do so it has not been possible to identify any staff involved in Adam Strain's care other than the names already provided to the Inquiry.
