I refer to your letter dated 28<sup>th</sup> October 2011 Ref: INQ-0494-11 (copy enclosed for your ease of reference).

I would like to draw your attention to Paragraph 1 of your letter when you state "I am instructed that the Trust can find no record of Doctor Savage requesting a chest x-ray prior to transplant". In relation to this, I advise that in his Inquiry witness statements, Doctor Savage confirms on more than one occasion that a chest x-ray was performed on Adam Strain as part of the standard pre-transplant checks.

I would be grateful if you would provide the Inquiry with an explanation as to why, in light of what is contained in Doctor Savage's witness statements, the Trust can find no record of a chest x-ray being requested prior to transplant.

I look forward to receiving a response by 5<sup>th</sup> December 2011.

## RE: INQUIRY INTO HYPONATRAEMIA RELATED DEATHS

I refer to the above and your letter of 14<sup>th</sup> October 2011 (BPC-0026-11).

1) I am instructed that there is no record of an x-ray being performed prior to Adam's transplant surgery on 27<sup>th</sup> November 1995. A form to request a pre-treatment chest x-ray completed by Dr O'Neill on 26<sup>th</sup> November 1995 is filed in the patient's record (057-019-028). Its presence in the medical records and the fact that the reverse of the form (057-019-029) has not been completed by a radiographer indicates that it was not submitted to radiology and that therefore no x-ray was performed. There is no Kv and mas (voltage and current x time) or radiographer's initials written on the back of the form. Under lonizing Radiation Regulations an examination would not have been performed without an appropriately completed request form which would have been retained by the department. I am instructed that the Trust can find no record of Doctor Savage requesting a chest x-ray prior to transplant.

2) Original Portable chest x-ray film performed at 9:30 pm on 27<sup>th</sup> November 1995 enclosed herewith on your undertaking to return same to us and to take full responsibility for its safekeeping. Please note that no copy has ever been made of this

film and it is therefore imperative that it is retained safely.
