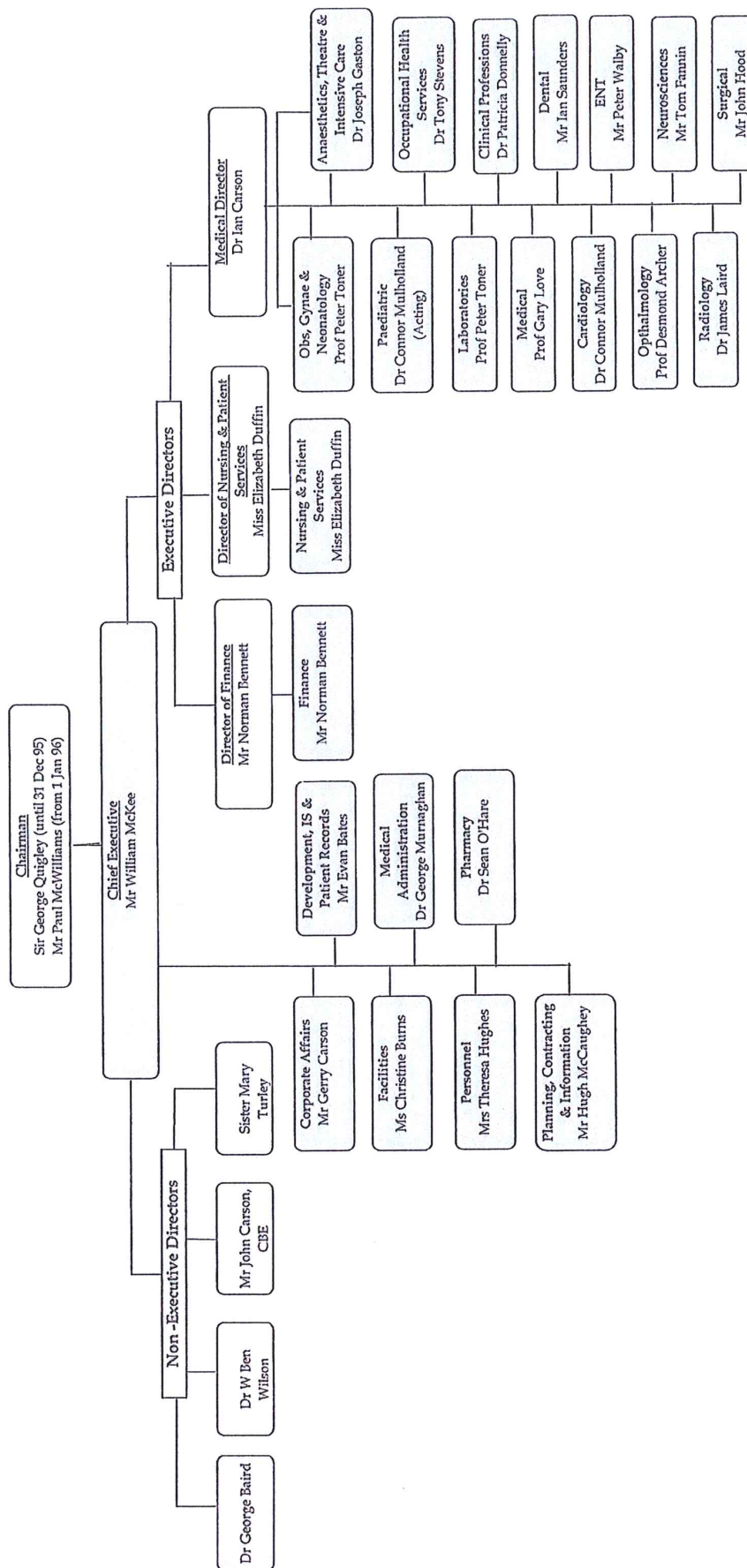

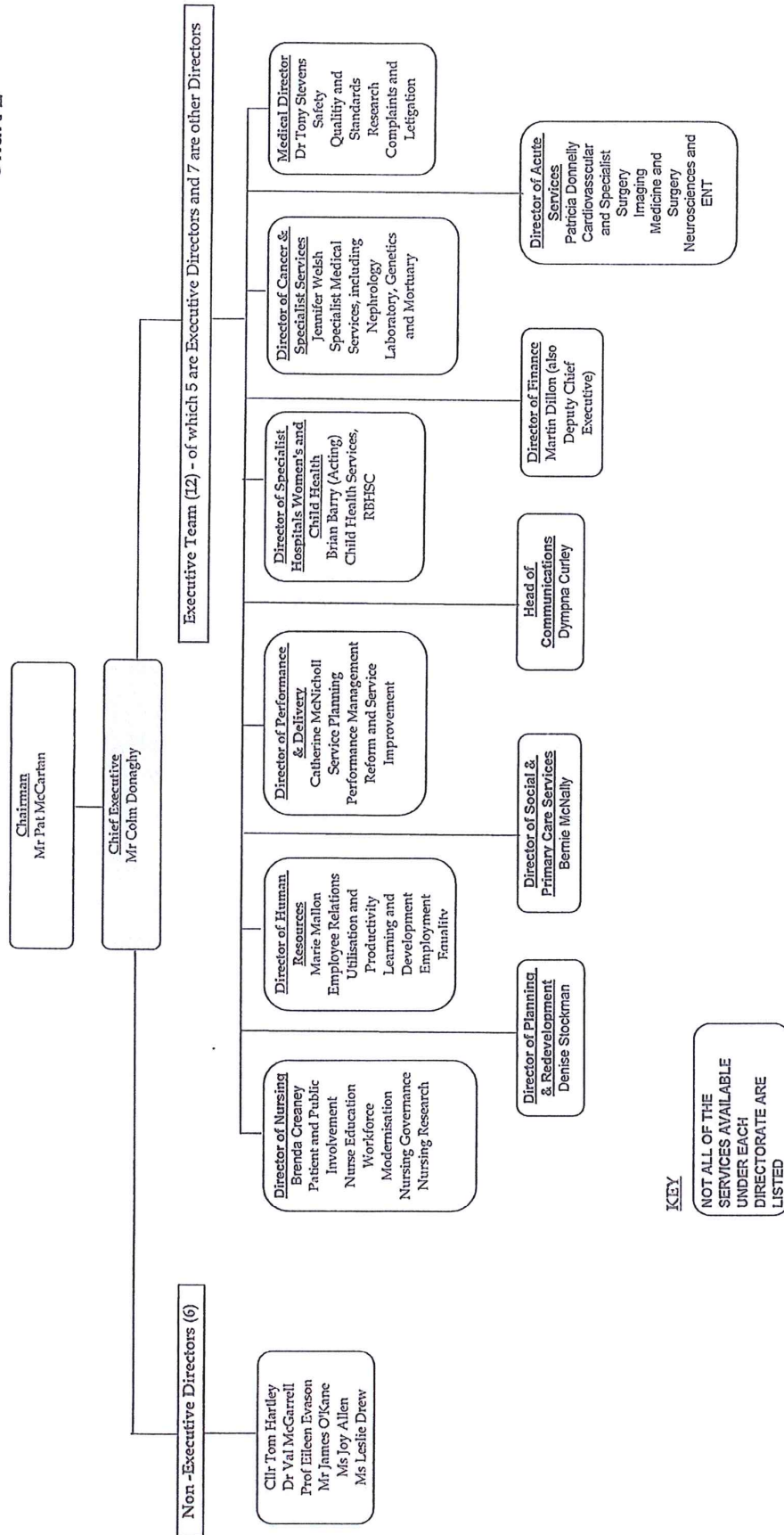
Royal Group of Hospitals Trust - Organisation Structure 1995/96
