Dear Bernie

Further to our telephone conversation this afternoon, in relation to the 1st paragraph of Ms Dillon's letter, I am advised by my client that despite strenuous efforts on the Trust's part, unfortunately it has been unable to produce the information on the 'thumbnail info' which Professor Savage states he provided to the Corporate Affairs Department of the Royal Group of Hospitals.

These efforts have involved the Trust searching through its own archive system. In addition, the Trust's IT Department has also carried out extensive searches against the relevant individuals' e-mail addresses in order to ascertain whether the information had been contained there. However, the Trust has been unable to locate any such information to which Prof. Savage has referred in his evidence.

As regards the second paragraph of Ms Dillon's letter, I await receipt of confirmation from Prof. Savage's solicitor, as to how exactly this information was provided to the Trust. I have spoken to Ms Wylie about this today, and I shall revert to you further with a formal response to the above letter, as soon as I hear from her. I trust this is in order in the meantime.
