

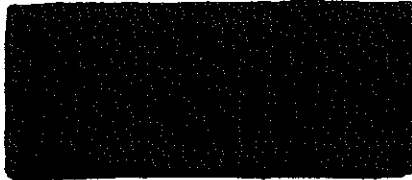

POST GRADUATE TRAINING

9th January 1978 - 31st January 1978

Locum House Officer in the Geriatric Medical Unit, Belfast city Hospital.

1st February 1978 - 31st January 1979

House Officer in the Belfast City Hospital. The first three months were spent in wards 6 and 9 (Urology), and also covering wards 12 and 15 (Orthopaedics) at night and weekends. Then followed three months as holiday relief House Officer in surgery, during which time I had experience in general surgery, paediatric surgery and urology ward work.

The second six months were spent as a medical House Officer, first in wards 10 and 18 under Dr A P Grant and Dr R Lowry, where I gained experience in general medicine and diabetes and was also involved in the care and treatment of patients with haematological diseases.

The last three months were spent in wards 8 and 14 (Cardiology) with Drs Morton, Murtagh and Scott; where I was actively involved with the cardiac arrest team and gained experience in the coronary care unit.

1st February 1979 - 31st July 1980

S.H.O. in Anaesthetics in Belfast City Hospital. During the first six months of this attachment, I received training in anaesthesia for general, vascular, orthopaedic and urological surgery and was introduced to the management of patients in the Intensive Care Unit.

The following twelve months were spent as theatre anaesthetist in the City and Musgrave Park Hospitals, where I had training in orthopaedic, gynaecological, paediatric and ENT anaesthesia, as well as gaining experience in anaesthesia for trauma surgery and intensive care work.

1st August 1980 - 31st July 1981

S.H.O. in Anaesthetics in the Royal Victoria Hospital, Belfast. Further training was received in anaesthesia for general, orthopaedic, vascular, gynaecological, ophthalmic, ENT paediatric and trauma surgery. I also gained further experience in intensive care.

1st August 1981 - 31st July 1982

S.H.O. in Anaesthetics in Craigavon Area Hospital. More experience in anaesthesia for general, trauma, gynaecological and ENT surgery was gained. I was also actively involved in management of intensive care patients. During this year, I also received training in obstetric anaesthesia. In April 1982, I was successful (at last) in passing the Primary FFARCSI examination.

1st August 1982 - 31st July 1983

Registrar in Anaesthetics in Belfast City Hospital. Further training in anaesthesia for the above specialities was received, and I also was introduced to epidural and spinal anaesthesia in obstetrics, general surgery, and urological surgery. I also gained considerable experience in renal transplant anaesthesia.

1st August 1983 - 31st July 1984

Registrar in Anaesthetics in Lagan Valley Hospital, Lisburn. I was involved in anaesthesia for general, trauma, gynaecological, ENT and obstetric surgery; and was Junior Representative on Medical Staff Committee.

1st August 1984 - 31st July 1985

Registrar in Anaesthetics in Waveney Hospital, Ballymena. As well as further training in anaesthesia for general, trauma, gynaecological ENT and obstetric surgery, I was also involved in the running of the intensive care unit and the obstetric epidural service. I was also introduced to anaesthesia for day case surgery at the Massereene Hospital, Antrim.

1st August 1985 - 31st January 1986

Locum Registrar in Anaesthetics in Lagan Valley Hospital, Lisburn. (see above).

1st February 1986 - 31st July 1986

Locum Registrar in Anaesthetics in Royal Victoria Hospital, Belfast. Further experience in the Regional Intensive Care Unit, in addition to anaesthesia for general, trauma, orthopaedic and vascular surgery.

The second three months of this attachment were spent in the Mater Infirmorum Hospital, Belfast.

1st August 1986 - 31st July 1987

Locum Registrar in Anaesthetics in Belfast City Hospital. Further experience in the specialities listed previously was gained including provision of obstetric epidurals. In May 1987 I passed the Part III FFARCSI examination, after several attempts.

1st August 1987 - 31st July 1988

Locum Senior Registrar in Anaesthetics in Royal Victoria Hospital. In addition to specialities listed previously, I received training in anaesthesia for cardiac and thoracic surgery and neurosurgery. Further experience was also gained in the Regional Intensive Care Unit. The last three months of this year were spent in the Mater Infirmorum Hospital, Belfast.

1st August 1988 - 31st August 1988

Locum Consultant Anaesthetist in Downe Hospital, Downpatrick.

1st September 1988 - 31st July 1989

Locum Senior Registrar in Anaesthetics in the Belfast City Hospital and Musgrave Park Hospital, providing anaesthesia for general, trauma, orthopaedic, gynaecological, paediatric, ENT, urological, vascular, thoracic and day case surgery; also obstetric anaesthesia including epidural service.

1st August 1989 - 31st July 1990

Registrar in Anaesthetics in Belfast City Hospital. Further experience gained in anaesthesia for general, trauma, orthopaedic, gynaecological, paediatric ENT, urological, vascular, thoracic and day case surgery; also obstetric anaesthesia including epidural service. For the first 6 months I was Anaesthetic Rota Organiser and Junior Representative to the Division of Anaesthetics.

1st August 1990 - 31st July 1991

Senior Registrar in Anaesthetics at Ulster Hospital, Dundonald. This Hospital is the regional centre for plastic surgery and maxillo facial surgery. I have gained considerable experience in the anaesthetic management of this type of surgery, both in theatre and post operatively in the Intensive Care Unit. Further experience was also gained in anaesthesia for general, gynaecological, orthopaedic, trauma, ENT and paediatric surgery and obstetrics, including an epidural service.

The hospital also has a busy pain clinic and I was involved with the care of chronic pain patients and gained experience in invasive techniques used in the management of acute and chronic pain. I was rota organiser and the Junior Representative at meetings of the Anaesthetic Division.

1st August 1991 - 31st July 1992

Present appointment. Senior Registrar in Anaesthetics at Royal Victoria Hospital, Belfast. I will be spending 3 month attachments to neuro-surgical, paediatric and cardiothoracic anaesthetic specialities and am at present on the on-call rota for the Regional Intensive Care Unit. From 1st November 1991 to 31st January 1992, I will be on the on-call rota for paediatric and obstetric anaesthesia in the Royal Belfast Hospital for Sick Children and the Royal Maternity Hospital, respectively.

At present I am rota organiser; and also one of two junior anaesthetic representatives to the Directorate of Anaesthetic, Theatre and Intensive Care Services.

1st July 1992 - 21st July 2012.

Consultant Anaesthetist, Erne Hospital, Enniskillen.

One of three consultant anaesthetists, with no junior staff.

On 1-in-3 on-call rota.

By 2008, anaesthetic department had expanded to eight consultants and five staff grade anaesthetists.

21st July 2012 – present date.

Consultant Anaesthetist, South West Acute Hospital, Enniskillen.
