I agree that there is confusion.

Ms Dillon did not assert that you held your client's files, simply that on the basis of the information given to the Inquiry that there a number of files we do not have. All Trust documents customarily are sent through DLS to the Inquiry so if there any outstanding Belfast or Western Trust documents, we would expect to receive them through your office.

I have a note that the index forwarded yesterday by Ms Bolton pertains to the Western Trust file, not DLS. Is it the case that this title is in fact correct and the list does reflect the content of the DLS file?

Perhaps we can take this matter forward later when the lists are available.

Dear Bernie, further to our telephone conversation, there appears to be further confusion which has arisen here, in relation to which files DLS holds, following

on from Ms Dillon's letter (reference above) of even date.

I informed you this morning that we are holding the following files relating to RF's inquest:-

1. DLS File relating to RF's Inquest- Client: Western Trust

2. File relating to RF's inquest- Client: Belfast Trust- but, please note that this is a Brangam Bagnall file

Just to clarify this does not mean that we are holding either the Western Trust's original Inquest file or the Belfast Trust's original Inquest file, and I would ask that this inaccuracy contained in Ms Dillon's letter be corrected.

Furthermore, I cannot recall informing Mrs Conlon this morning that the title to the Index furnished yesterday afternoon is incorrect. This document is a Schedule of a DLS Inquest file, and I am not sure how this misunderstanding has arisen. Please can this inaccuracy also be corrected.

Please also can you refer to our Mr Maginness's letter dated 24th July 2012 (in response to JOH-0253-12) which clearly sets out exactly which files we hold for Raychel. This letter had correctly stated the position.

Also, the Inquiry has already been given ALL files held by the Western Trust, in this matter, and there are no further two files to be handed over- I cannot recall informing Mrs Conlon this morning that there were a further two Western Trust files which you don't have. Please can this also be corrected.

In conclusion, I understand that I am to furnish you with an index of the Western Trust's Inquest file (as supplied by Ms T Brown), as well as an Index of the DLS (Client: Western Trust) Inquest file by 4pm today. The latter index must state which documents the Western Trust claims privilege over- that is my understanding but perhaps Ms Dillon could kindly confirm.

Please also can Ms Dillon phone me urgently if she requires any further clarification.
