

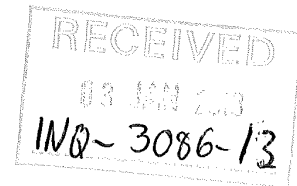

**RE: INQUIRY INTO HYPONATRAEMIA RELATED DEATHS – RAYCHEL
