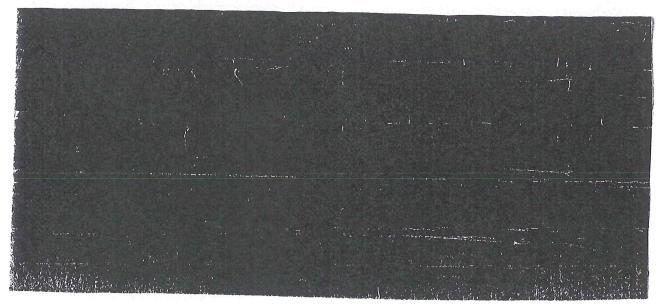
It was noted that the minutes of the previous meeting had been adopted at the April Trust Board meeting and were provided for information only.

(a) Terms of Reference ~ Mr Mullan

Mr Mullan reminded members that Mr Fee briefed March Trust Board on the outcome of the Coroner's inquiry into LC Case. The Trust is currently working with General Medical Council (GMC) in relation to clinical issues raised. Separately, it was recommended that a Root Cause Analysis be undertaken. The case provides the opportunity to reflect on a number of system/process concerns that have arisen. In order to move this forward a Steering Group chaired by Mrs Irvine is to be established. The steering group will be supported by external advisors in clinical governance. The timeframe is envisaged as 4-6 months. Mr Mullan advised that the outcome would be communicated to outside authorities. Mr Mullan advised he will make a public statement once the family has been made aware of the plans. Mr Mullan confirmed that the recommendations will be presented to the CSCG committee and passed to Senior Management Team for implementation.
