

## RE: INQUIRY INTO HYPONATRAEMIA RELATED DEATHS - RAYCHEL FERGUSON

I refer to my letter of 17<sup>th</sup> May 2013 in response to Mr McLoughlin's letter of 9<sup>th</sup> May 2013 (BMcL-0085-13) and your subsequent letter of 17<sup>th</sup> May 2013 (AD-0582-13).

I am instructed that in responding to your letter of 17<sup>th</sup> May 2013 (AD-0582-13) the Trust's pharmacy department repeated the original search which generated the information contained in my letter of 17<sup>th</sup> May 2013. Despite the fact that the repeated search process applied appears identical to that originally conducted the results are different. The system on which this information is contained is antiquated and I understand that it is difficult to extract information from same. Another member of staff in the Pharmacy department has repeated this search to ensure reproducibility.

The Trust now instructs that the information contained in my letter of 17<sup>th</sup> May 2013 is incorrect. The correct information, which should have been supplied in response to Mr McLoughlin's request (BMcL-0085013), is that the Pharmacy department supplied a total of 6493 bags of No 18 Solution to the RBHSC between 1<sup>st</sup> January 2000 and 31<sup>st</sup> July 2001. I have enclosed a chart and table showing a month by month breakdown of the number of bags supplied by the Pharmacy department to the RBHSC.

With regard to your letter dated 17<sup>th</sup> May 2013 (AD-0582-13) I am Instructed that this information will have to be extracted from the system manually. This is a difficult process and I understand that it will take time to produce an accurate and reliable result. The Trust confirms that it is working on obtaining this information and will provide it to you as soon as possible.


Please accept the Trust's apologises for the erroneous information contained in my aforementioned letter of 17th May 2013.
