## 5 REGIONAL AUDIT COMMITTEE - PUBLICATION OF WORK PROGRAMME.

Dr McConnell noted that the Regional Audit Committee had not published reports. Dr Watson was concerned that the Committee did not appear to be possessed of any direction, and perhaps needed to be restructured. It was suggested that one meeting be held each year to set out a programme of work for that year. Dr McClements said the Committee was intended to be the driving force behind audit in Northern Ireland but probably lacked the infrastructure to accomplish this effectively. It was agreed that Dr Watson should contact Dr Keegan, as new chairman of the Committee, to discuss in particular its

relationship with the Area Audit Committees. Dr McConnell said the Committee should be encouraged to formulate a strategy. It was felt that this could be best achieved by a small executive committee. It was agreed that Dr Keegan should be invited to a future meeting of DsPH/DHSS.

Dr Telford said she would like to see a common approach to the selection of topics for audit and suggested that RMSC might be able to co-ordinate. Dr McConnell said RMSC considered this role outside its remit, and he suggested holding an informal meeting of DsPH. He felt it was also necessary to encourage audit by addressing the system of incentives now in place. Equally, he felt there should be a system of penalties if audit was not carried out to a sufficiently high standard.




8 THERAPY IN SCHOOLS.






9 CONSULTANT APPOINTMENT PANELS - ROLE OF REGIONAL ADVISER IN SMALLER SPECIALTIES.

Introducing this item, CMO informed DsPH that SAC Paediatrics had recommended a review of Child Health

Services in Northern Ireland, to be carried out as soon as possible. Dr Telford and Dr Watson felt that the prospect of such a review would delay the implementation of the Combined Child Health Service. Dr Watson suggested that the review should not commence until the assimilation of CMOs and SCMOs had been completed, and the Regional Strategy and Maternity Services Policy Circular had issued. It was agreed that work should not yet commence on the review of child health services in Northern Ireland.

Dr Telford said the Southern Board's Director of Social Services had proposed to issue a joint report with the Director of Public Health. She invited comments. Dr Watson pointed out that the DPH report was a statutory requirement, whilst the DSS report was required only by the Board. Dr McConnell said Dr Gaffney had examined this issue and had concluded that some sections of each report, such as those on demography, were broadly the same. Dr Watson concluded that there was room for some co-operation, but that the independence of the DPH report should be protected. This was agreed.


