

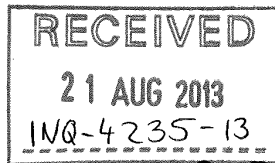

This information completes the responses to the requests contained in your letter of 1st July 2013.

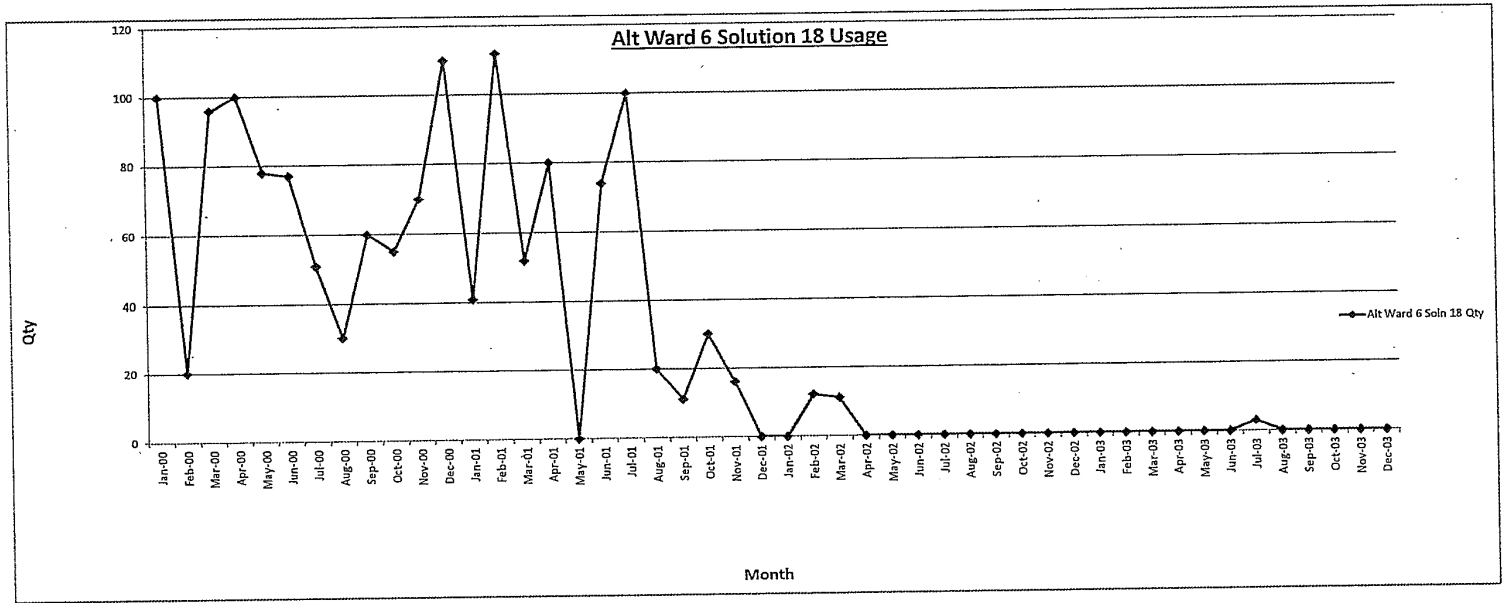
