INQUIRY INTO HYPONATRAEMIA-RELATED DEATHS: LETTERS TO SIR HUGH ORDE, JOHN O'HARA QC, MS JOANNA MITCHELL AND MR & MRS ROBERTS

Issue:

On Monday 4 August you met with the mother and grandmother of Conor Mitchell and the parents of Claire Roberts. You undertook to write to the Chief Constable seeking to expedite the case of Claire Roberts and you also gave an undertaking to both families that you would do what you could to ensure there are no further delays in progressing with the Inquiry. A draft letter to John O'Hara is therefore also included. You have since requested letters of sympathy and apology for both families. These are also attached.

Timescale:

Routine

Presentational Issues: There continues to be media interest in the inquiry.

Recommendation:

That the Minister issues the attached

letters.

Background

1. As you are aware, this Inquiry is now considering four cases, of which Claire Roberts is the only one still being investigated by the police.

- 2. On 14 January 2008 you wrote to the Chief Constable seeking an update, which was supplied on 22 February. At that time the PSNI thought further expert opinion would be required. They were also consulting the family on their views. Mr & Mrs Roberts advised you that they believed the PSNI were still waiting on a neurologist's report. Mr Roberts indicated that the family had advised the police they would prefer the investigation to be picked up by the Inquiry.
- 3. Both families asked that there be no further delay and you advised that the Report of the Inquiry is expected by September 2009, which is when John O'Hara has indicated previously. However in view of the continued difficulty in identifying a venue, it is recommended that a reminder of the expected timescale should be sent to John O'Hara, which is in accordance with current Cabinet Office guidance that "The responsible Minister can stress discipline in the management of the Inquiry....for example by setting a target completion date."
- 4. Following the meetings, at which the families of both children were understandably distressed and angry, you asked for letters

to be issued expressing your sympathy and an apology. Two draft letters are attached for your consideration.

Recommendation

5. That draft letters (attached) be issued to Sir Hugh Orde, John O'Hara QC, Ms Joanna Mitchell and Mr & Mrs Roberts.

INQUIRY INTO HYPONATRAEMIA-RELATED DEATHS

You wrote to me on 22 February 2008 about the progress being made in investigating the deaths of children who died from hyponatraemia. In particular, you advised that in the case of Claire Roberts, further expert opinion was being sought and that you were also consulting with the family.

You will be aware that on 30 May 2008, John O'Hara QC announced the resumption of his Inquiry and in particular, that two new cases were being added (Claire Roberts and Conor Mitchell).

I have met with both families and in my conversation with the Roberts, was given to believe that they had indicated to the PSNI that they would be content for the further investigation of their daughter's death to be undertaken by the Inquiry, although they recognised that the PSNI may first have to complete its own investigation and seek the views of the PPS.

I would be grateful therefore if you could let me know the present position regarding progress with Claire's case. I have been advised by John O'Hara that his Inquiry hopes to do its preparatory work in the autumn 2008 with public hearings early in 2009. You will understand that Mr and Mrs Roberts have already been through a very difficult time, yet still face the Inquiry process. Anything that could be done to expedite completion of the PSNI investigation would therefore be appreciated greatly.

Thank you for your attention to this matter.

I hope that you enjoy your summer break and look forward to the Inquiry making significant progress in the autumn.


