"I have said in my witness statement to the Inquiry that I recall receiving the Chief Medical Officer's guidance document in March 2002, and that I forwarded this to Clinical Directors in all the clinical specialties. However in view of the absence of documentary evidence to verify the circulation of guidelines to areas other than Paediatrics, I accept Mr Justice O'Hara's interpretation as set out in this document.
