  - (a) Please comment on whether the nursing care plans at (REF:301-135-010 to 301-135-012; 301-135-015 to 301-135-017; 301-135-022 to 301-135-024; 301-135-029 to 301-135-031; 301-135-036 to 301-135-038) arein your experience representative of a preoperative nursing care plan in the RBHSC in November 1995.

  (A) I have no memory of the preoperative care plans being used in Musgrave Ward, RBHSC in 1995 therefore do not know whether they are representative of preoperative careplans used in RBHSC in 1995.
  - (b) The nursing care plans (Ref:301-135-010 to 301-135-012; 301-135-015 to 301-135-017; 301-135-022 to 301-135-024; 301-135-029 to 301-135-031; 301-135-036 to 301-135-038) have typed comments in the 'Problem', 'Goals' and 'Nursing Action' sections and handwritten comments in the 'Evaluation' section. Please state, in relation to November 1995:
    - (i) Who was generally responsible for the typed comments
    - (ii) Who was generally responsible for the handwritten comments
    - (iii) Whether the care plans would be provided to nursing staff with the typed comments already entered
