I was not present at the Departmental Board meeting on 27 February 2004 but on reading the minutes of that meeting (004-019-236) I was made aware of the death of Lucy Crawford. I cannot remember how or when I became aware of the deaths of Adam and Raychel.

I did not consider it within my remit as Chief Dental Officer to take any steps to investigate the deaths of these children, other than take part in any Departmental Board discussions or decisions.

I would not have discussed with colleagues or been included in discussions with colleagues regarding the children's deaths.
(iv) In your role as a member of the Departmental Board, explain what information you received or solicited about the procedures, investigations and events that followed the deaths of Adam, Lucy and Raychel.
I would have been aware, from Departmental Board papers of 27 February 2004(004-019-236), that the Department was meeting with Sperrin Lakeland Trust to discuss the death of Lucy Crawford.
At the Departmental Board meeting on 28 May 2004 (004-020-238) there was an update on the media coverage of the death of Lucy Crawford.
(v) Again in your role as a member of the Departmental Board, explain what steps you took to discover why the children died and to ensure that any lessons would be learned.
As a Board member I was aware that a decision was made to hold an inquiry into the deaths of these children.
