Many thanks for your recent letter. I no longer reside in N. Ireland and have just returned home for a few days at Christmas to see your letter regarding the inquiry into the hyponatraemia-related deaths in 1996, hence the delay in my response.

As I have not seen any original documentation with my records/signature, the only comment I can make with regard to this incident fifteen years ago is I was a student nurse on Allen ward at this time. This means all nursing care provided would have been under the supervision of a qualified staff nurse, and, all documentation in the child's notes would have required a signature by the staff nurse I was working with during that particular time.

As I have not seen the full documentation and furthermore was not a qualified staff nurse I am unable to provide further comment on this individual case. I trust this of some assistance with your inquiry.
