I was appointed as a Consultant Paediatrician on 1st March 1996. Prior to this I had been a Consultant in Canada from Sept 88 – February 96.

I first met Claire and her family 30<sup>th</sup> May 1996.

(3) Describe your role in the care and treatment of Claire.

Acting as Consultant Paediatrician assessing whether she had attentional difficulties given her background of moderate learning difficulties and history of seizures from age 6-months to 4-years.

- (4) "It was nice to meet Claire on first occasion at the Thursday morning clinic at the Ulster, May 30<sup>th</sup> [1996]. Claire, 9 years 5 months, is known to have moderate learning difficulties and history of seizures from 6 months to 4 years of age. She has been off Epilim for the past year and seizure free." (Ref: 090-013-018)
  - (a) State when, in your knowledge of Claire and her history and condition, was the last known occasion of her suffering a seizure prior to her admission to the Royal Belfast Hospital for Sick Children on 21st October 1996.

By report from parents, Claire's last seizure occurred when she was 4-years old

Ritalin at the time of her admission to the Royal Belfast Hospital for Sick Children on 21st October 1996.

I cannot say from the records if Claire had restarted Ritalin but my belief is that she has not.

- (c) If not, state the date on which Claire's:
  - (i) prescription
  - (ii) administration

of Ritalin was stopped.

Ritalin trial was stopped on October 1<sup>st</sup> or 2<sup>nd</sup> 1996 – following phone discussion with Claire's family.

I was aware that Claire had died but have no record of the exact time or circumstances. I Met with Claire's parents following her death. I was not able to add any insight into why she had died.
